# Look & Listen Tour Summary: Themes and Concepts

- Natural Systems and Shoreline Protection
  - Restore and preserve natural areas (wetlands, barrier beaches, invasive species control)
- Public Safety Infrastructure
  - Identify emergency road networks; maintain and protect; state-of-good repair
- Communication
  - Create information sharing networks for informing year-round and seasonal residents regarding programs, strategies, incentives, etc. for implementing resiliency measures.
- Resilient Infrastructure
  - Design boat launches and docks to function at variable water levels – for recreation and commercial activities
  - Wastewater infrastructure (public sewers vs private septic systems)

# Look & Listen Tour Summary: Themes and Concepts

- Resilient Design
  - Guide development and preservation of properties within the risk area (LWRPs, zoning, voluntary programs)
- Economic Resources and Tourism
  - Dredge critical channels to allow boat access to inland waterbodies
  - Accessibility of boat launches
